## **HAUNTED MAJESTIC GHOST HUNT EVENT RULES, REGULATIONS AND WAIVER**

Thank you for your interest in the *Haunted Majestic Ghost Hunt Event* at the historic Majestic Theatre. Please review the information contained within this packet and return only the waiver form. The rest of the packet is yours to refer to for compliance of rules and regulations.

The Haunted Majestic Ghost Hunt Event at the Majestic Theatre is hosted by the Majestic Theatre, Inc. and its board of directors and volunteers. Proceeds from these events benefit the restoration of the historic theatre.

### **RESERVATIONS**

- Pre-registration for this event is required as space is limited. The reservation/ticket fee is \$95.00 per participant which must be purchased in advance of the event. Tickets will not be sold at the door.
- Upon purchase of ticket through the Majestic Theatre's website, an original signed waiver must be received by the Majestic Theatre within seven (7) days of ticket purchase to confirm your space.
- All ticket sales/reservations are final. Refunds and/or rescheduling are not available. You may transfer your reservation to another individual in-person at the Majestic Theatre office within five (5) days of the event.
- Tickets can be purchased online at [www.MajesticChillicothe.net/tickets](http://www.MajesticChillicothe.net/tickets), over the phone at (740) 772-2041 or in-person at the Majestic Theatre's office at 230 N. Plaza Blvd. Limited to four (4) tickets/reservations per transaction.

### **EVENT DETAILS**

The Haunted Majestic Ghost Hunt Event is a special fundraiser to allow amateur ghost hunters the opportunity to explore the historic theatre's "haunted" past. There are no guarantees of experiencing anything paranormal during the event. There will be no special effects nor a haunted house experience as part of this event. It is you, the investigator, with the opportunity to explore the historic building.

- Check-in will take place from 7:00pm – 8:00pm.
- All participants must be checked by 8:00pm – no exceptions.
- 8:00pm – 9:00pm recap of rules & regulations, pizza and soft drinks will be provided by the Majestic Theatre. A quick tour of the facility will be provided.
- 9:00pm – 5:00am Lights out - participants can hunt ghosts throughout permitted areas of the building.

### **RULES & REGULATIONS**

- Participants must be eighteen (18) years of age or older. No minors will be allowed to participate in this event.
- Participants must have paid reservations and signed waiver on file with the Majestic Theatre. You will need to bring along your photo ID to check-in to the event.
- Participants must abide by all rules of the event.
- Participants can access areas on all floors of the building, however specific off-limit areas will be marked with caution tape. Any participants who enters these areas will be asked to leave and escorted off the grounds.

- Participants may leave at any time during the Haunted Majestic Ghost Hunt, however those who leave the premises will not be allowed to regain entry into the building. There are no exceptions.
- This event is not a sleepover, no accommodations are provided to participants.
- The historic Majestic Theatre does contain some hazards including, but not limited to, steep staircases, low ceilings, and uneven surfaces.
- Drug, alcohol, weapons are prohibited. Anyone suspected of being under the influence of drugs or alcohol will be subjected to immediate removal from the event.
- Only small camera bags will be allowed into the event. Participants should leave any extra items in their vehicles.
- Participants may use only battery-operated devices during the event. No equipment requiring electricity will be permitted beyond the main lobby. If your equipment requires charging, you may return to the main, well-lit lobby to recharge. It is suggested to bring along additional charged batteries with you.
- Participants must bring along a flashlight and batteries to use during the event. Cell phone flashlights are not permitted.
- Participants may carry their phones during the event, but the phone must be completely silenced including vibration. Use of cell phones will be allowed in the main lobby and courtyard areas only. Disturbances made by using cell phones may result in participant being asked to leave.
- No two-way radios are permitted.
- No seances or Ouija boards are allowed at this event.
- Removal of Majestic Theatre property or damage to property will result in immediate removal from the event and possible legal action.
- Smoking and Vaping are not permitted within the Majestic Theatre. Participants may use the courtyard for such purposes.
- Please respect the building and its history. Please do not touch stained glass windows or attempt to open windows. Equipment on site are either historic or in-use, please refrain from touching.
- Some restrooms on upper floors are non-functioning. Please use only working restrooms which are in the main lobby.
- Any inappropriate behavior will result in the immediate expulsion of the participant(s) from the event.

#### **PHOTOGRAPHY/VIDEOGRAPHY/AUDIO**

All photography, videos, and/or audio recordings captured during the event is for personal use only. Any use of images, videos and/or audio recordings for personal profit without written permission from the Majestic Theatre, Inc. Board of Directors may result in legal action. The Majestic Theatre, Inc. has the right to demand removal of any footage published by participants for any reason.

#### **SUGGESTIONS**

- Dress appropriately for the season and activity. Participants should avoid wearing articles of clothing that could be a potential tripping hazard.
- Wear comfortable/sturdy shoes. There are many stairs and floors to the building.
- Navigate the event in pairs or small groups. Participants should avoid "hunting" alone.
- Please be respectful to other participants by keeping noise levels to a minimum. Anyone found scaring people on purpose or violate noise levels repeatedly will be asked to leave.

As a condition of attendance, the Participant assumes the risk of injuries to person or property arising out of his or her use of the premises and does hereby release the Majestic Theatre, Inc., its trustees, board of directors, employees/volunteers, agents, sponsors, and successors from and against any claim, demand liability arising out of such injury and will protect and indemnify the Majestic Theatre, Inc. and those persons released with respect to any claim, demand or liability arising out of such injury including death.
